2. The Chairman Project Procurement Committee (PPC) on behalf of the Sri Lanka Air Force now invites sealed bids/proposals from eligible and qualified bidders for Purchase of Asphalt Concrete (Binder Course) with Polymer Modified Bitumen (PG 76-10) for Development of Hingurakgoda Airport Project (Stage 05, 06 & 07)

3. **The delivery period:** 06 Months (Items shall provide on request within this period)

4. Bidding will be conducted through National Competitive Bidding (NCB).

5. **Qualifications requirements include:**

- a. Documents specified in eligibility and qualification requirements specified in Section V.
- b. A margin of preference for eligible locally produced goods **“shall not” be applied.**

9. If stated in the Data Sheet the Bidder shall submit a certificate from the manufacturer to demonstrate that it has been duly authorized by the manufacturer or producer of the Goods to supply these Goods in Sri Lanka.
10. If the testing charges / samples are required by the Bidding Document (Please refer Section IV) the relevant conditions given in the Bidding Document shall be complied with in all respects without any reservation. The original cash receipt for testing charges issued by the Director Finance of the SLAF shall be attached to the original bid.
11. The successful bidder shall undertake to perform the resulting order/ contract with all-reasonable skill, diligence and care in accordance with sound industry practice to the satisfaction of the SLAF and accept full responsibility for the satisfactory quality of such goods/services as delivered /performed by them. Any non-conformity/ malfunction/ defect/ deficiency noticed in the goods delivered/ services rendered shall be promptly remedied by the successful bidder upon the receipt of written notice from the SLAF.

	<b>2. Source of Funds</b>	2.1 Payments under this contract will be financed by the source specified in the BDS.
	<b>3. Ethics, Fraud and Corruption</b>	<p>3.1 The attention of the bidders is drawn to the following guidelines of the Procurement Guidelines published by National Procurement Agency: - Parties associated with Procurement Actions, namely, suppliers/contractors and officials shall ensure that they maintain strict confidentiality throughout the process;</p> <p>- Officials shall refrain from receiving any personal gain from any Procurement Action. No gifts or inducement shall be accepted. Suppliers/contractors are liable to be disqualified from the bidding process if found offering any gift or inducement which may have an effect of influencing a decision or impairing the objectivity of an official.</p> <p>3.2 The Purchaser requires the bidders, suppliers, contractors, and consultants to observe the highest standard of ethics during the procurement and execution of such contracts. f. **Anti-stripping agent.** Any anti-stripping agent or additive (anti-strip) shall be heat stable and shall not change the asphalt binder grade beyond specifications.

When the project requires asphalt mixtures of differing aggregate gradations and/or binders, a separate JMF shall be submitted for each mix. Add anti-stripping agent to meet tensile strength requirements.

The JMF shall be prepared by an approved laboratory that meets the requirements of paragraph 2.b. The asphalt mixture shall be designed using procedures contained in Asphalt Institute MS-2 Mix Design Manual, 7<sup>th</sup> edition.

Should a change in sources of materials be made, a new JMF must be submitted to the Engineer for review and accepted in writing before the new material is used. After the initial production JMF has been approved by the Engineer and a new or modified JMF is required for whatever reason, the subsequent cost of the new or modified JMF, including a new control strip when required by the Engineer will be borne by the Contractor.

The Engineer may request samples at any time for testing, prior to and during production, to verify the quality of the materials and to ensure conformance with the applicable specifications.

The JMF shall be submitted in writing by the Contractor at least 30 days prior to the start of paving operations. The JMF shall be developed within the same construction season using aggregates proposed for project use.

***The JMF shall be dated, and stamped or sealed by the responsible professional Engineer of the laboratory and shall include the following items as a minimum:***

- Manufacturer’s Certificate of Analysis (COA) for the asphalt binder used in the JMF in accordance with paragraph 1.c Certificate of asphalt performance grade is with modifier already added, if used and must indicate compliance with SLS 1643:2019 For plant modified asphalt binder, certified test report indicating grade certification of modified asphalt binder.
- Manufacturer’s Certificate of Analysis (COA) for the anti-stripping agent if used in the JMF in accordance with paragraph 1.d
- Certified material test reports for the coarse and fine aggregate and mineral filler in accordance with paragraphs 1.a
- Percent passing each sieve size for individual gradation of each aggregate hot bin; percent by weight of each and/or hot bin used; and the total combined gradation in the JMF.
- Specific Gravity and absorption of each coarse and fine aggregate.
- Coating and stripping test
- Percent by weight of flat particles, elongated particles, and flat and elongated particles (and criteria).
- Percent of asphalt.
- Number of blows
- Laboratory mixing and compaction temperatures.
- Supplier-recommended field mixing and compaction temperatures.
- Plot of the combined gradation on a 0.45 power gradation curve.
- Graphical plots of air voids, voids in the mineral aggregate (VMA), and unit weight versus asphalt content. To achieve minimum VMA during production, the mix design needs to account for material breakdown during production.
- Type and amount of Anti-strip agent when used.
- Date the JMF was developed. Mix designs that are not dated or which are from a prior construction season shall not be accepted.

**e. Control charts**

The Contractor shall maintain linear control charts for both individual measurements and range (i.e. difference between highest and lowest measurements) for aggregate gradation, asphalt content, and VMA. The VMA for each day will be calculated and monitored by the QCLaboratory.

Control charts shall be posted in a location satisfactory to the Engineer and kept current. As a minimum, the control charts shall identify the project number, the contract item number, the test number, each test parameter, the Action and Suspension Limits applicable to each test parameter, and the Contractor's test results. The Contractor shall use the control charts as part of a process control system for identifying potential problems and assignable causes before they occur. If the Contractor's projected data during production indicates a problem and the Contractor is not taking satisfactory corrective action, the Engineer may suspend production or acceptance of the material.

**i. Individual measurements**

Control charts for individual measurements shall be established to maintain process control within tolerance for aggregate gradation, asphalt content, and VMA. The controlcharts shall use the job mix formula target values as indicators of central tendency for the following test parameters with associated permissible Action and Suspension Limits:

**3. ASPHALT PLANT OPERATION, MATERIAL MANAGEMENT AND INSPECTION**

**a. Asphalt plant.**

An approved mixing plant of the automatic batch type shall be used for the preparation of mix. Mix shall have the capacity sufficient to supply the paver continuously. The asphalt mixing plant shall generally comply with and be operated in accordance with “Asphalt plant manual (MS3) “. Published by the American Asphalt Institute, including following items.

**i. Inspection of plant**

The Engineer, or Engineer’s authorized representative, shall have access, at all times, to all areas of the plant for checking adequacy of equipment; inspecting operation of the plant: verifying weights, proportions, and material properties; and checking the temperatures maintained in the preparation of the mixtures.

**ii. Storage bins and surge bins**

The asphalt mixture stored in storage and/or surge bins shall meet the same requirements as asphalt mixture loaded directly into trucks. Asphalt mixture shall not be stored in storage and/or surge bins for a period greater than Four (4) hours. If the Engineer determines there is an excessive heat loss, segregation, or oxidation of the asphalt mixture due to temporary storage, temporary storage shall not be allowed.

**b. Aggregate stockpile management.**

Aggregate stockpiles shall be constructed in a manner that prevents segregation and intermixing of deleterious materials. Aggregates from different sources shall be stockpiled, weighed and batched separately at the asphalt batch plant. Aggregates that have become segregated or mixed with earth or foreign material shall not be used.

A continuous supply of materials shall be provided to the work to ensure continuous placement.

**c. Hauling equipment.**

Trucks used for hauling asphalt shall have tight, clean, and smooth metal beds. To prevent the asphalt from sticking to the truck beds, the truck beds shall be lightly coated with a minimum amount of paraffin oil, lime solution, or other material approved by the Engineer. Petroleum products shall not be used for coating truck beds. Each truck shall have a suitable cover to protect the mixture from adverse weather. When necessary, to ensure that the mixture will be delivered to the site at the specified temperature, truck beds shall be insulated or heated and covers shall be securely fastened.

**d. Preparation of asphalt binder**

The asphalt binder shall be heated in a manner that will avoid local overheating and provide a continuous supply of the asphalt binder to the mixer at a uniform temperature. The temperature of modified asphalt binder shall be no more than 350°F (175°C) when added to the aggregate.

**e. Preparation of mineral aggregate**

The aggregate for the asphalt shall be heated and dried. The maximum temperature and rate of heating shall be such that no damage occurs to the aggregates. The temperature of the aggregate and mineral filler shall not exceed 350°F (175°C) when the asphalt binder is added. Particular care shall be taken that aggregates high in calcium or magnesium content are not damaged by overheating. The temperature shall not be lower than is required to obtain complete coating and uniform distribution on the aggregate particles and to provide a mixture of satisfactory workability.

**f. Preparation of Asphalt mixture**

The aggregates and the asphalt binder shall be weighed or metered and mixed in the amount specified by the JMF. The combined materials shall be mixed until the aggregate obtains a uniform coating of asphalt binder and is thoroughly distributed throughout the mixture. Wet mixing time shall be the shortest time that will produce a satisfactory mixture, but not less than 25 seconds for batch plants. The wet mixing time for all plants shall be established by the Contractor, based on the procedure for determining the percentage of coated particles described in ASTM D2489, for each individual plant and for each type of aggregate used. The wet mixing time will be set to achieve 95% of coated particles.

**g. Trial Section**

The trial section shall be carried out to ensure the following. The size of the trail section will be at least **50m** in length or more as decided by the engineer. The control strip shall be placed in two lanes of the same depth as per the design.

- (1) Confirm the mix is workable and can be compacted to a satisfactory density.
- (2) Establish the best rolling patterns for the trial section rollers by measuring in field density (using non-nuclear density gauge device)
- (3) The control strip will be considered acceptable by the Engineer if the gradation, asphalt content, and VMA are within the action limits specified in paragraph Section 2.a.1 and Mat density, air voids, and joint density as specified in section 2.d.

**4. GENERAL TENDER CONDITIONS FOR ASPHALT BINDER COURSE**

- 1. All bidders are to intimate the location of Asphalt Plant from which the asphalt shall be supplied.

5. The awarded substantially responsive bidder shall be carried out a mix design through a reputed organization, which is to be complied with the given standard specifications.
6. Test reports shall be submitted for Polymer Modified Bitumen which are compiled to given standard specifications (PG 76-10).
7. The awarded substantially responsive bidder is required to carry out the following testing test for Performance Grade Bitumen(PG76-10) for every 40000Kg through the reputed third party laboratory. Further test results are compiled to below mentioned specification.
